Full-Time Program

2023/2024

All Ballet Rockland students receive quality training and equal, individualized attention in classes. While some students choose to learn the art of ballet for pure enjoyment, others pursue training with more ambitious goals in mind. To accommodate the needs of these aspiring students, we offer a pre-professional program.

The pre-professional program is optional but strongly encouraged for those seeking a more rigorous ballet education. Each level of the curriculum is carefully planned and includes a minimum number of weekly classes, guidance, and assistance with goal-setting and future planning, as well as connections with professional cross trainers, physical therapists, and nutritionists. These mandatory classes are tailored to produce dancers with strong technique and muscle memory and give each student an opportunity to explore and expand their artistry, partnering abilities, and knowledge of ballet.

Pre-Professional students are offered more performance and workshop opportunities throughout the season. They are assisted with applications and auditions for recommended dance intensives, college dance programs, professional and company endeavors, and performance opportunities outside of Ballet Rockland.

Many hours of training and dedication are required to achieve a high level in any craft, and Ballet Rockland's pre-professional program is customized to each student's individual journey and goals. This personalization requires much attention, research, and time both in and outside of the studio by all Ballet Rockland faculty. While this program is intensive, we strive to help our students find balance in their lives and ensure they can achieve realistic dance goals in a healthy way.

As always, weekly classes for all ages are available for part-time students.

Information and Guidelines

Ballet Rockland Faculty takes the safety and training of its students very seriously. The key to a strong and successful outcome is consistency. There are many wonderful classes outside of Ballet Rockland that can complement a dancer's training; however, there are also many classes that offer conflicting techniques and inadequate training standards that can confuse students, cause irreparable bad habits, and potentially injure a student. It is crucial that dancers, parents, and Ballet Rockland faculty are all on the same page and working together as a cohesive team. This requires open communication. While Ballet Rockland supports its dancers having experiences outside of Ballet Rockland, students **MUST** consult with Ms. Tew before making decisions about their training. Taking classes outside of Ballet Rockland should be thoroughly discussed with Ms. Tew prior to doing so to ensure the best interests of the student and their training are met.

To maintain minimum requirements of the pre-professional program, attendance is mandatory in the assigned number of classes for each curriculum level. Please contact us if you are expecting to be late or absent. Dancers who are more than 5 minutes late will be asked to sit in class and take notes.

Pre-professional students are offered several opportunities to participate in performances throughout the school year. Performing in front of an audience enhances students' confidence and their self-expression and artistry while fostering a sense of teamwork and accomplishment. If a dancer commits to a performance, attendance at all rehearsals and performances is required unless otherwise discussed with Ms. Tew or the rehearsal director.

If a dancer sustains an injury, they must still attend class, observe, and take notes to continue their training while they recover.

Code of Conduct

Please initial each of the following signifying that you have read, understood, and agree to uphold the expectations of Ballet Rockland, LLC.

_____ Dancer must maintain consistent attendance, keep a positive attitude, participate to the best of their ability, and put forth 100% effort, energy, and enthusiasm.

_____ Dancer will be punctual. For safety and injury prevention, it is imperative that all dancers participate in the entire class. Dancer understands that if they arrive more than 5 minutes late, they will be asked to sit, observe, and take notes.

_____ Dancer will adhere to the dress code. This includes hair and attire. Dancers not adhering to the dress code cannot participate in class.

_____ Dancer is expected to demonstrate respect for all instructors, assistants, staff members, and fellow students, and dancer is expected to focus and pay attention to the teacher's instructions.

_____ Dancer will be friendly, warm, and welcoming to other dancers at the studio and in their classes. We encourage dancers to establish new friendships with their peers in their classes, and we enforce teamwork and fairness.

_____ A dancer observing a class in progress is expected to be quiet and courteous to the participants, teachers, and assistants.

_____ Dancer must treat studios, premises, and possessions of all other dancers with respect, care, and consideration. Dancer will neatly store belongings and respect the belongings of others.

_____ Dancer will clean any mess they create at the studio. No drinks, food, gum, or candy are allowed in studios or waiting rooms except during special programs. Water bottles are permitted.

_____ Parents: please do not try to talk to our teachers during class time. If you need to meet with an instructor, please call the studio to set up a time or send an email. It is important that teachers can perform their duties teaching class uninterrupted.

_____ **We have a zero tolerance policy regarding bullying. We are a drama-free studio and strive to maintain a healthy and safe environment for all our students and staff. Our policy also extends beyond the studio to include behavior on social media and at other venues. Instigating, participating in, and/or encouraging drama or bullying that impacts the ballet studio, its students, or staff and faculty will lead to immediate consequences up to and including expulsion.**

Failure to comply with this code of conduct may result in permanent expulsion from Ballet Rockland, LLC without refund.
